Our department is blessed with active and dedicated students! Since 2001, 154 of our 306 EAM Department graduates have completed internships at some point in their academic career at Central. This includes not only the internships for which they received departmental credit, but also those internships they may have completed while studying abroad, or on the Chicago Semester program. However, these numbers don't include those students who may have had positive work experiences in college, but received no academic credit for them.

What's more, of those who complete at least one internship, fully one-third completed two or more internships. Thirty nine students completed two internships, twelve completed three internships, and one resourceful soul completed FOUR internships during her career at Central—two while studying abroad, and two while on campus in Pella.

This year 17 EAM students completed internships or co-ops for academic credit, and several students completed internships or service learning projects while studying abroad in the fall

semester in Vienna and London (spring 2007 numbers were not available at press time).

We said hello to a new colleague; bade a fond farewell to another; significantly revised and revamped parts of the EAM curriculum; made progress in seeking a person of excellence to become the first holder of the Martin Heerema Endowed Chair in Entrepreneurship; increased our involvement in Central College's international programs, inaugurated a "welcome home" reception for EAM students returning from abroad; and held yet another successful Advisory Council meeting.

Personnel: We began this academic year with one goodbye and one hello. At the Faculty Workshop Luncheon in August, the EAM faculty joined the Central community in honoring Suzanne Wallace, who took early retirement last year due to serious medical problems. While we were sad to say goodbye to Suzanne, we were happy to honor her at the luncheon by reading heartfelt tributes from her former students. Suzanne plans to spend much of this summer in Italy, basking in the sunshine at a Tuscan villa.

In August, we said hello and welcome to our newest EAM Department colleague, Dr. David Kauper. David came to Central after completing a Ph.D. in economics at University of California - Riverside. He now teaches many of the courses previously taught by Rich Glendening. Suffice it to say that we are very glad that David chose to join the EAM faculty.

This spring, economist Dr. Brian Peterson was officially granted tenure by the Board of Trustees. Brian spent a year at Central in 1996-97 before moving to Indi-

ana's Manchester College. Brian returned to Central in 2004 and now serves as EAM's senior economist. In the true liberal arts tradition, he is an active supporter of campus interdisciplinary initiatives such as the environmental studies program. Please join us in congratulating Brian on his well-deserved achievement of tenure!

Endowed chairs: Excitement continues to build regarding the potential impact of EAM's three endowed chairs. As you can read in an update elsewhere in *the Link*, Jann Freed continues to develop the Mark and Kay DeCook Endowed Chair in Character and Leadership Development. Early this summer, EAM Department faculty will hold a retreat to begin identifying criteria for the Don Butler Endowed Chair in Economics, with a national search to follow in Fall 2007.

We happily anticipate that within the next few weeks we will be able to announce the name of the first holder of the Martin Heerema Endowed Chair in Entrepreneurship. The new holder of the Heerema Chair will inaugurate an exciting new program teaching entrepreneurship skills to Central College students and people in the local area. We are indeed blessed to have three endowed chairs based in our department and are confident that the chair holders will have a significant long term positive impact on both the department and the college.

Curriculum: This year, the EAM Department made significant steps toward improving its curriculum to meet the needs of today's students. The campus curriculum committee gave its stamp of approval to Debela Birru's updated version of the

International Management major, providing students with new options for learning about global business. Several new economics courses also received approval, including quantitative methods in economics and economic history. In response to increasing student interest in nonprofit organizations, the Not For Profit Management Program was reconfigured to become an official college minor. And, in recognition of the growing demand for student experiences blending academics with real-world learning, the department added an Accounting Co-op and an Economics Co-op to its existing Business Management Co-op in the *College Catalog*.

Scholarship funds: Finally, we would like to extend a heartfelt note of thanks to all of you who contributed to the special scholarship funds established last year to honor two of our most distinguished former EAM colleagues. I am happy to report that the Rich Glendening Scholarship Fund is nearing the \$29,000 mark, while the Barb and Don Butler Scholarship Fund now exceeds \$45,000. It is truly gratifying to be able to report on the generous contributions of EAM alumni like you. The entire EAM Department is grateful that you have honored our former colleagues so generously with your donations!

I encourage you to read the many articles in this issue of *the Link* that highlight the achievements and activities of EAM Department students and faculty. It is an honor and a pleasure to be associated with such accomplished people!

EAM Department Actively Involved in Study Abroad

In fall of 2006, the department hosted a reception for students who were studying abroad during the previous spring and summer terms. Students brought photos that were posted in the department suite and had the chance to share highlights from their many experiences. The department appreciated the opportunity to listen to the students' stories and hear how travel abroad has changed them in some way. Many students used the phrases, "life-changing," "unforgettable," and "well worth it" to describe their experiences.

Since the reception was so well received by everyone involved, the department plans to continue this event and possibly even expand it so that students interested in studying abroad will come to hear the stories shared.

While only three students traveled abroad in fall 2006, the department has 16 traveling abroad this semester. What's more, next year a record number of students will be traveling abroad both from the College and from this department. Approximately 80 Central students will be traveling in the fall, compared with about 60 in a normal fall. Eight are traveling abroad from this department, spread over many different study abroad sites: 1 each in the Leiden, Granada, Yucatan, and Wales, and 4 in London.

Not only does the department strongly support the international programs, but three department members are study abroad liaisons. Each of the eight Central College Abroad sites has a faculty liaison to serve as a link to campus. The liaison works with faculty

members to promote program sites, and works with students to help them understand what will happen when they get to their destination country. Faculty liaisons also actively work with Central College Abroad to promote study abroad overall.

Accounting professor Kevin Den Adel was just named faculty liaison to the program in Hangzhou, China, and will begin his four-year term in the fall. Management professor Jann Freed and economics professor Brian Peterson are currently in their first year as liaisons to the programs in Mérida, Yucatan and Vienna, Austria, respectively. Jann Freed has traveled to the Yucatan numerous times—in fact, some of you may have traveled with her!

Jann Freed Provides an Update on the Mark and Kay De Cook Chair in Character and Leadership Development

As the holder of this endowed chair, my goal is to start some new leadership initiatives on campus. In October, we launched the Mark and Kay De Cook Distinguished Speaker Series with Po Bronson, author of the national best seller *What Should You Do With Your Life?* This was a well attended event by both the College and the

community of Pella.

As this will be an annual series featuring speakers who reflect various aspects of leadership, the next distinguished speaker for the fall is Dr. Armando José Baqueiro de Cárdenas '70, from Mexico City. Some of you may remember that Dr. Baquero received an honorary degree at last year's commencement exer-

cises.

I developed and taught a new course in the fall called Holistic Leadership based on a study I started during my last sabbatical. I am teaching this as an honors seminar, and I hope I am able to teach this course on a regular basis and continue to work on developing more leadership learning experiences on campus.

The Martin Heerema Endowed Chair in Entrepreneurship, and Remembering Martin Heerema

A national search was conducted this year for the Martin Heerema Endowed Chair in Entrepreneurship, and currently is in its final stages. It is hoped that by the time many of you read this, the position will be filled. Two students, Ian Dielschneider and David Baker, and three faculty members, Bob Maurer, Jaclyn Rundle, and Brian Peterson, served on the search committee this year, and the department is grateful for the effort they gave in the process. The department looks forward to having more news to report in the 2008 *link*.

In the meantime, the department wishes to express its condolences to the Martin Heerema family, because on April 16, 2007 Martin John Heerema passed away. Martin was born in Pella in 1911, graduated from Pella High School in 1928 and then worked for the Rolscreen Company (now known as Pella Corporation). Martin enrolled at Central and graduated in 1934 with majors in Mathematics and Chemistry (at that time

Central did not have a Business Management major). During that time, in June, 1933, Mart and Elva May Van Houweling eloped to Moberly, Missouri to get married.

After graduation, Mart returned to work at Rolscreen for four more years. In 1938 Mart left Rolscreen and went into the automobile business, selling Dodges and Chryslers with his father-in-law, A.B. Van Houweling. In 1941 Mart became a field agent for the Internal Revenue Service. Soon afterward, he entered the United States Navy until he was discharged as a Seaman First Class in December 1944.

Following his military duty Mart returned to the A.B. Van Houweling Garage, and from 1953 to 1963 Mart served as the company purchasing agent. Then Mart returned to Central College and served as Vice-President for Financial Affairs from 1963 until he “retired” in 1970.

Over time, Mart not only was a partner in the Pella Canning Factory (which now houses some of the offices of Heritage Lace, Inc.), but also received his real estate broker's license in 1941. With that, Mart remained active in the Pella real estate market, buying and selling properties until 1993.

Mart was a charter member of the Pella Golf and Country Club; the Pella Rotary Club, serving as the club's president and being named both a Paul Harris Fellow and Rotarian of the Year; and the Pella Opera House. He was member of the Van Veen-Van Hemert American Legion Post No 89; the Pella Historical Society, also serving on its board; the Pella Community School Board for nine years; and the Pella Cemetery Association for 23 years.

Mart was a sports enthusiast; he was responsible, in part, for the formation of the Pella Little League. Finally, he had a great love for Central College athletics, and was one of the founders of the “Central Club.”

2007 Advisory Council Meeting a Success

The council includes a broad representation of EAM Department alumni and other business and civic leaders. Ashley Warner '07 Reflects on her Principal Financial Co-op

[EN: Ashley has worked since January in the Commercial Real Estate Unit at the Principal Financial Group in Des Moines. This is an excerpt from a journal entry for April.]

When I first began the internship back in January, I had never even imagined that a department devoted just to closing a loan existed. I had no idea about the processes that were involved or the documents and requirements that had to be met. I was overwhelmed by all the legal vocabulary and financial jargon that was constantly being tossed around.

The biggest part of my learning experience has been by asking

questions. Many times throughout the semester I was told, "Asking questions is how the other (more senior) members of the department know how much you are learning and how much you understand."

It was difficult for me to be so open about asking specifics in the beginning because I was always worried that I would take up too much of someone's time. Then as time passed, I realized that nearly everyone wanted me, as an intern, to understand as much of what was going on as possible. And once I started to understand

what was going on and the steps and due diligence that is involved, I began to see how the tasks that I had been doing the whole time fit in.

Overall this month, I feel like I have gained a much better understanding of the whole loan closing process. I am finally catching onto the legal terms and understanding the basic purposes of the loan documents that are created internally. This semester has definitely set a good foundation for the permanent position that I have accepted within the department.
